Economy 7 Times

Day: Winter (8am – 1am), Summer (9am- 2am)
 Night: Winter (1am – 8am), Summer (2am – 9am)
 Economy 7 provides seven hours of low cost electricity (times may vary slightly)

Powershift Times

Peak: Mon-Fri (4pm-7pm), Normal: Mon-Fri (8am-4pm) & (7pm-midnight) & Sat/Sun (8am-7pm)
 Low: Mon-Fri (midnight-8am) & Sat/Sun (7pm-8am)

The times above are winter time, add one hour for summer time e.g. Low applies between 1am and 9am every day. Powershift is only offered for relevant pre-payment meters.
