Your discounts are set out in the table below ("Tariff Discounts") and are calculated by reference to the SSE Airtricity standard tariff ("SSE Airtricity Standard") which may be amended from time to time during the Term, but this will not affect your Tariff discount. Your Tariff Discounts will be applied from the date that SSE Airtricity is registered as your supplier and will continue for a period of one (1) calendar year from that date ("Term"). - ("Cancellation Period") by writing to us by post or email or by contacting us on 0345 850 8935 (local rate) and no termination charge will apply. You may use the cancellation form provided to you but you do not have to. However if you leave the Tariff after the cancellation period or the Agreement is ended by you at any time before the end of the Term, you may be charged a termination charge of £40. This will be applied to your account. If you cancel a direct debit, a £125 deposit will be added to your account.
- 7. After the expiration of the Term or if you leave the Tariff before the end of the contract, your SSE Airtricity account will be switched to the SSE Airtricity standard (Smartsaver Standard) electricity rates applicable at that time.
